Thank you for your Freedom of Information request dated 12th April for information about Automation Strategy. Please find below City of Doncaster Council's responses to the questions you have raised.

1. **What is the Council's strategy and roadmap for AI and Process Automation?**

The Council has outlined its approach and plan for AI and Process Automation, which revolves around enhancing the Customer Experience Strategy. This entails focusing on incorporating RPA and into the development of digital processes.

2. **If neither have yet been adopted, when will they be?**

RPA and AI are both currently being explored.

3. **Who are/will be the key stakeholders and decision makers for these technologies?**

ICT & Customer Services

4. **What technologies/vendors are currently in use (eg Blue Prism, Open AI, Druid AI) and which version, and are they on premise or cloud hosted?**

Prototypes are being explored with Azure OpenAI, Microsoft Co-Pilot, Azure Cognitive Search, AWS certified transcribe solution. For RPA, we use Power Platform and a prototype using UiPath. They are all cloud hosted.

5. **How many processes have been automated and how many licences have been purchased?**

There are 80 -100 RPA processes in production and development. All licensing is dealt with through stand license model. The licensing information will be on the contract register on [Supplying the Council - Procurement - City of Doncaster Council](#) .

6. **How many additional processes does the council expect to have automated in the next 12 months?**

We don't have that information available at the moment.

7. **What is the typical licence utilisation rate for RPA, where it exists?**

All licensing is dealt with through stand license model. The information will be on the contract register on [Supplying the Council - Procurement - City of Doncaster Council](#) .

8. **What/who does the automation team consist of, who leads it, and who do they report into (if external delivery, which supplier)?**

An inhouse development team with 2 * senior developers and 2 * developer. They report to Michael Roodt (Development & Deployment Manager).

9. **How are any bots maintained?**

Continuously update and adapt the processes within AI and RPA tools.

10. **When are any licences due for renewal?**

All licensing is dealt with through stand license model. The information will be on the contract register on [Supplying the Council - Procurement - City of Doncaster Council](#) .
