Thank you for your request for information regarding List of Operational Issues (Finance Team).

Section 12 (1) of the Freedom of Information Act allows for a request for information to be refused where the cost of supplying this information exceeds the appropriate limit. After carefully considering your request for information the City of Doncaster Council has decided that to respond to your request would exceed the appropriate limit as defined in the Freedom of Information (Appropriate Limit and Fees) Regulations 2004. The regulations allow a request for information to be refused where the cost of supplying this information exceeds £450 (or 18 hours of officer time).

The cost limit applies in this case because (the City of Doncaster Council does not hold a central record of this information. In order to determine the record, documents etc that we may hold regarding budget issues a total of 260 members of staff will need to review their emails, service requests, records, other documents etc. It is estimated that each member of staff will require a 2 hour investigation of their records. As 260 members of staff require review in order to determine this information this would result in a total time of approximately 540 hours which would exceed the time limit).

Although City of Doncaster Council cannot detail every operational challenge faced by finance teams within the cost limit, examples of the issues faced would include:-

- Recruitment difficulties due to fewer people in the labour market,
- Reduced staff levels due to reductions in budgets,
- Additional work during and after COVID-19 (e.g. providing grants to local businesses).

At the more strategic level, City of Doncaster Council publishes on its website the annual budget setting report that is presented to Full Council. The 'Revenue Budget 2024/25 – 2026/27' report is available by clicking on the following link:
