Thank you for your Freedom of Information request dated 4 November 2024, for information about home education.

Please find below City of Doncaster Council's responses to the questions you have raised.

Request:

1. For each academic year including and between 2013/2014 and 2023/2024 - how many children were registered with your council as being home educated?

City of Doncaster Council do not have data for the years before 2022/23, due a change in recording system.

Below are the figures for the two most recent years, counting all pupils who were Electively Home Educated at any point during the year.

The number with SEND is based on children who were recorded with an EHCP or SEN support.

The information marked with * is exempt from disclosure under Section 40(2) of the Freedom of Information Act 2000. The information requested is third party personal data (i.e. personal data about someone other than you). Section 40 (2) provides that information which is third party

personal data is exempt from disclosure if one of three conditions is satisfied. In this case the following condition applies:

1. Disclosure would contravene one of the data protection principles

The information you have requested is personal data and has not been provided in this case, as City of Doncaster Council believes that the release of such low numbers to responses could specifically lead to the identification of a child who otherwise would not expect their personal information to be released into the public domain.
