9. In your opinion how much has BNG impacted on the validation of planning applications? (On a scale from 1-10, 1-Low, 10-High).

RESPONSE: The Freedom of Information Act provides a right of access, subject to certain exemptions, to recorded information held by public authorities. It does not require public authorities to express opinions or comment upon matters therefore as this question requires the expression of an opinion/comments, this information is not held.

10. Does you authority have any provisions in place to aid agents / applicants with application validation processes?

RESPONSE: Yes – please see How do I apply for planning permission? - City of Doncaster Council.

11. Does your authority have any processes in place to help with the delivery of BNG? E.g. land bank sites.

RESPONSE: This is an area under development. The Council is progressing its own habitat bank and applied to DEFRA to be a Responsible Body for the purposes of Conservation Covenants. Guidance has also been provided. Please see Mandatory Biodiversity Net Gain (BNG) - City of Doncaster Council.

12. Has your authority hired a 'specialist' in order to aid with the determination of BNG relevant applications?

RESPONSE: No, being delivered via in-house Ecologists.
