
This Order is made by City of Doncaster Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ('the Act') because it appears to that authority that The County of the West Riding of Yorkshire (Area 3) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i), namely, that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates.

The authority has consulted with every local authority whose area includes the land to which the order relates. The City of Doncaster Council hereby order that:

1. For the purposes of this order the relevant date is 18th March 2024.
2. The County of the West Riding of Yorkshire (Area 3) Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is confirmed and may be cited as City of Doncaster Council Public Footpath No. 13 Bawtry Definitive Map Modification Order 2024.

A footpath some 235 metres in length with a width of 1.2 metres commencing on Tickhill Road at the north-western corner of Menagerie Wood at grid reference SK 6448 9312 (point A on the order map) and proceeding in a generally south-easterly direction through the wood to the bend on Park Road close to the junction with Westwood Road at grid reference SK 6463 9295 (point B on the order map).

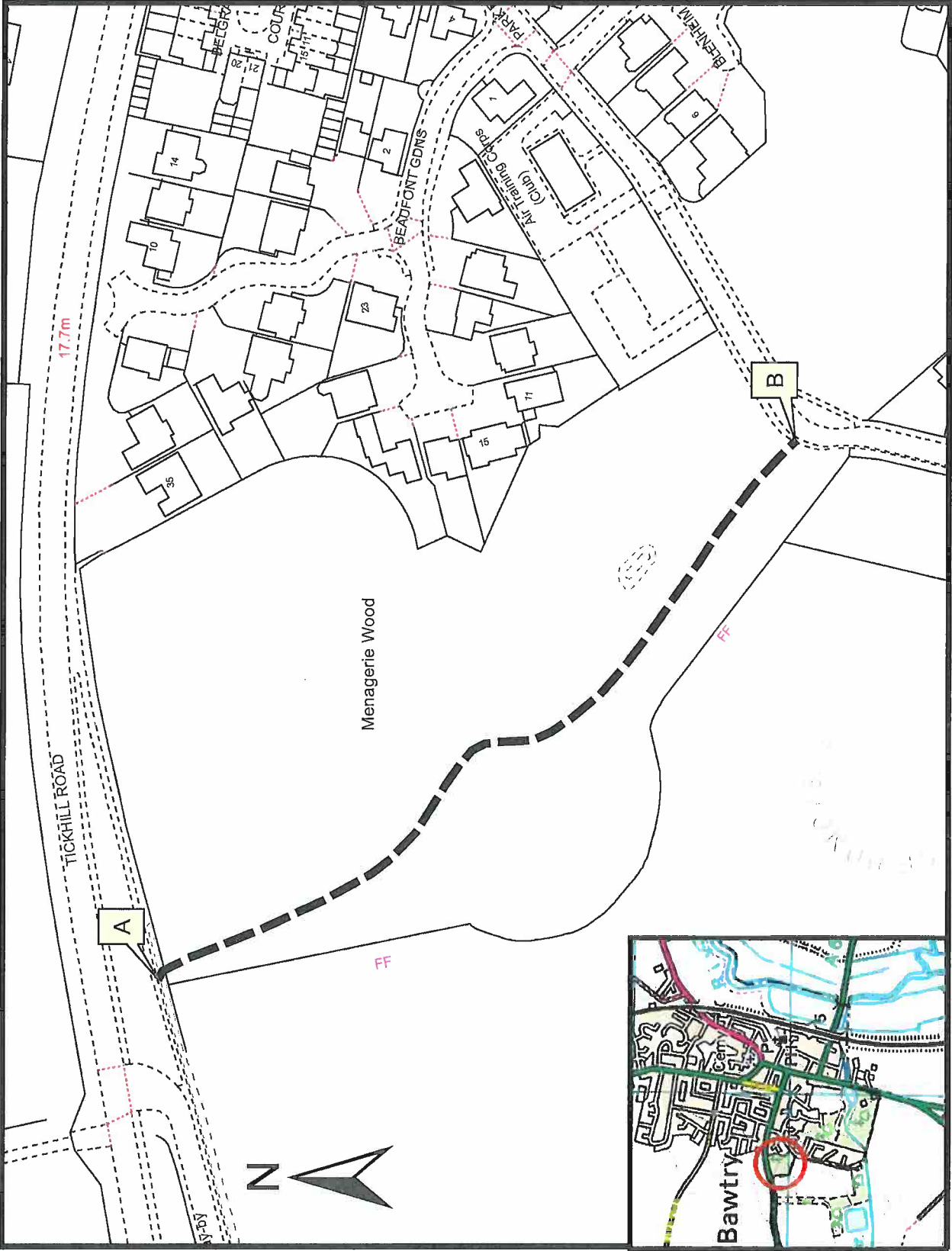
