# THE DONCASTER BOROUGH COUNCIL PUBLIC FOOTPATH NO 6 BARNBY DUN PUBLIC PATH DIVERSION ORDER 2003 VARIATION ORDER 2024

This Order is made by City of Doncaster Council under section 326 of the Highways Act 1980.

### BY THIS ORDER:

- 1. The Doncaster Borough Council Public Footpath No 6 Barnby Dun Public Path Diversion Order 2003, confirmed on 28th January 2004, is hereby varied:
  - (a) The map dated 9<sup>th</sup> July 2002 attached to the 2003 order shall be deleted and substituted with the map dated September 2024 attached to this order.
  - (b) In paragraphs 1 and 2 the words 'Barmby Dun' shall be deleted and substituted with the words 'Barnby Dun'.
  - (c) The following paragraph shall be added:
  - '3. The rights conferred on the public under this order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.'
  - (d) In the Schedule Part 1 Description of Site of Existing Path, all four lines shall be deleted and substituted with:

The full width of a section of Barnby Dun with Kirk Sandall footpath no. 6 commencing from Station Road at grid reference SE 6182 0893 (point E on the order map) and proceeding south-westerly for some 294 metres to grid reference SE 6158 0876 (point F on the order map), thence southerly for some 84 metres to grid reference SE 6158 0867 (point D on the order map).

(e) In the Schedule Part 2 Description of Site of New Path, the first four lines shall be deleted and substituted with:

'A footpath commencing from Station Road at grid reference SE 6183 0892 (point A on the order map) and proceeding south-westerly for some 39 metres to cross over Town End Drain at grid reference SE 6181 0888 (point B on the order map), thence south-south-westerly for some 79 metres to grid reference SE 6177 0881 (point C on the order map), thence south-westerly along the field edge for some 240 metres to grid reference SE 6158 0867 (point D on the order map).'

(f) The following shall be inserted in the Schedule:

### LIMITATIONS AND CONDITIONS

Grid reference SE 6183 0892 Grid reference SE 6177 0881

Kissing gate compliant with BS5709:2018 Kissing gate compliant with BS5709:2018'

2. This order shall come into effect on the date it is confirmed and may be cited as The Doncaster Borough Council Public Footpath No 6 Barnby Dun Public Path Diversion Order 2003 Variation Order 2024.


