## The National Wraparound Expansion Programme

The Wraparound Childcare Programme is proving successful across Doncaster with applications for funding being received from all types of provision including schools, nurseries and childminders. Positive relationships are being reflected with partnership working across the city, with some providers working together to deliver high quality breakfast and afterschool clubs for working families.

To date, funding has been allocated to 17 individual new expansion programmes across 13 school pyramids, which will result in the creation of an additional 590 new wraparound places. Engagement with providers has been extremely positive and the programme aims to allocate all remaining funding by the end of March 25, ensuring the overall target of 2087 new wrapround places is reached. This expansion programme is bringing wraparound provision into areas across Doncaster where

breakfast and afterschool clubs have either not previously been available or have not fully met the needs of families, and will continue to provide much needed support for working families.

Approximately £2m of funding has been allocated to the LA from DfE to promote wraparound expansion. All types of providers can apply for this funding – schools, PVI and childminders, or providers can work together in partnership.

Possible wraparound delivery models could include:

- School-based provision, delivered by school: Delivered by school staff on a school site and open to all children attending that school.
- School-based provision, delivered by private provider or childminder: Schools contract and work in partnership with a private provider or childminder who would pay them to operate wraparound provision on school premises.
   Operated and delivered by staff employed by the private provider (this provision must be Ofsted registered).
- Childminders: Provision delivered by childminders, signposted to parents by Local Authority and schools. Could be a group of Childminders working together on a single/community site.
- Cluster / hub model (on or off a school site).

Funding is being allocated to help either the expansion of existing wraparound provision or the creation of new provision, with the vision that this will become self-sustainable by 2026. Wraparound funding cannot be spent on equipment or supplies which are expected to last for more than 1 year, where the cost is more than £500, but it can be used to cover costs including staffing, training, and transport costs such as minibus hire (not purchase) or resources such as food. It can be used to contribute to running costs whilst demand for wraparound builds, pay for training, including specialist training to ensure staff can fully support children with additional needs. It can even be used to deliver the service.

Applications for wraparound funding to expand existing provision through extending opening hours or creating new places, or to create completely new wraparound provision, are being accepted now. #### Person Centred SEN Support Plan

In collaboration with Parents and Early Years Providers we have updated our early years person-centred SEN plan. As a service we are continuing to drive forward a strength-based approach for the child/children and the parents/families at the forefront.

Within the person-centred SEN plan 'All about me' section, there is the function of adding photographs, for example, family pets, people or resources that is important/special to the child. This brings the child's plan to life, and provides opportunities for sharing comments, and photographs with the child.

The expectation for providers would be when commencing the initial APDR cycle, the new person-centred SEN plan would be implemented. Existing SEN support plans are not required to be transferred over to the new format.

As a service we welcome and value your feedback on the person-centred SEN plan, this informs our future delivery of service and ways of working. Please complete the google questionnaire available on the local offer.

#### Early intervention Allowance (EIA) funding:

#### **Needs Descriptors**

There are four levels of need identified within the Early Years Needs Descriptors which align with The Graduated Approach:

- ➤ Universal
- Universal Plus
- ➤ Targeted
- ➤ Specialist

The purpose of the Needs descriptors is to ensure a consistent approach to the identification of the level of a child's needs. Once the child's needs are accurately identified appropriate strategies and intervention are put in place to ensure barriers to learning are removed at the earliest opportunity.

The early years needs descriptors must be used to inform the practitioners professional judgement in identify the child's levels of need. It is expected that strategies within the Needs descriptors are used. Within the EIA request you will need to identify the level of the child's need, for example, targeted or specialist, in conjunction with the child's SEN support plan this will inform the award of EIA amount of funding.

If you are submitting a request for EIA, you would complete the new online request form. As part of the criteria for EIA, it is a requirement within the child's SEN plan there is a review of the child's APDR meeting. If an APDR has not taken place, evidence of a conversation with your Area SENCO, must be evidenced.

The documents and or any supporting information must be emailed to the <u>earlyyearsrequest@doncaster.gov.uk</u> at the same time as the EIA request.

EIA funding is available or all Early Years providers for example childminders, private voluntary, independent settings and maintained school, until the end of the child's FS1 year.

#### Dear Provider,

We're pleased to announce that we will soon be using the Perspective Lite platform provided by Angel Solutions to write, seek approval of, and host our Focus Visit Reports/Rolling Action Logs.

Benefits of using the platform:

- Provides a single information sharing point with EY group providers that can be easily accessed.
- Only finalised documents will be stored which means there is no concern about version control and the provider and EYIT staff can be confident they are accessing the most up to date record for any audits or inspections.
- If a member of the team is absent / unavailable for any reason, the platform holds the latest versions of visit reports (including drafts) which means that other team members have essential, up to date information from which to provide advice or support.
- There is consistency in our interaction and reporting to providers which includes schools.

What happens next:

• Please provide your one preferred email address that will be the contact for the Notes of visit/action log. (We advise not to provide a shared email address that all staff can access due to confidential and sensitive information or providing a specific individual email address due to potential staff changes, unless this is an owners email).

- Nexus Angel Solutions (who provide the platforms) will create a Perspective Lite account for your setting and this will trigger a welcome e-mail. Please check your spam / junk emails too!
- When you receive this welcome e-mail please activate your account.

- There will be a brief training session where you will be shown how to access your reports and approve them. (Date to be confirmed.)
- For every report produced, you will receive an e-mail with a link to log into your account and provide any amends or approve the report. (This will be shown in the training session)
- You will be able to log into Perspective Lite as often as required to access your finalised reports. You can also download these to save.

Please make every attempt to access the training session, so you can ask questions if clarity is needed, but if this isn't possible, we will make a recording available via our Facebook page.

Julia Manning-Morton's career in the early childhood field spans 40+ years and diverse roles as a nursery practitioner, adviser and inspector; mostly in London, UK. She was previously course leader for **Early Childhood Studies** at London Metropolitan University and is now an **independent consultant, author, lecturer and trainer,** including being an associate trainer for Early Education, a Froebel Travelling Tutor, a committee member of Pikler (UK) and chairperson for a local playgroup.
