City of Doncaster Council (“the Council”) in exercise of its powers under Section 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1 The City of Doncaster Council (Various Roads, Doncaster) (Moving Traffic) (Consolidation) Order 2009 shall have the effect as though:-

(a) The following item was deleted from Schedule 1.12
Prohibition of Driving except for access

QUEEN STREET

From a point 37 metres northwest of its junction with St. Catherine’s Avenue for a distance of 97 metres in a north westerly direction

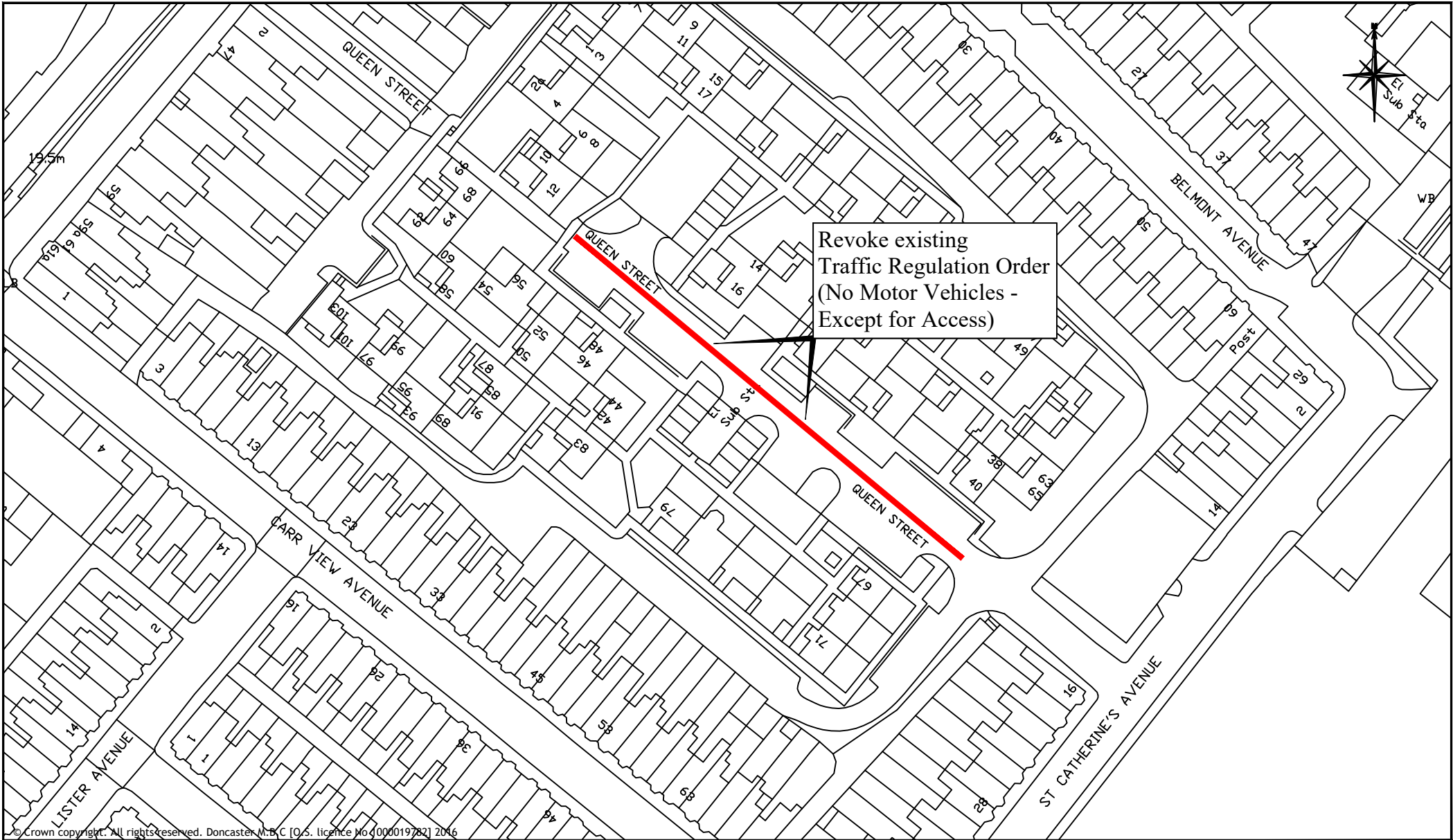

**PROPOSED REVOCATION OF PROHIBITION OF DRIVING
Queen Street, Balby**

STATEMENT OF REASONS

The proposals are intended to remove an existing restriction which is effectively redundant as, the section of carriageway in question is a dead end, so through traffic is not an issue and the current restriction is “except for access”, thereby allowing vehicular access for deliveries / collections etc. The proposal should neither compromise road safety, visibility, nor the free flow of traffic.
