City of Doncaster Council ("the Council") in exercise of its powers under Section 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1 The City of Doncaster Council (Various Roads, Doncaster) (Moving Traffic) (Consolidation) Order 2009 shall have the effect as though:-

(a) The following item was deleted from Schedule 1.12 Prohibition of Driving except for access


QUEEN STREET

From a point 37 metres northwest of its junction with St. Catherine's Avenue for a distance of 97 metres in a north westerly direction

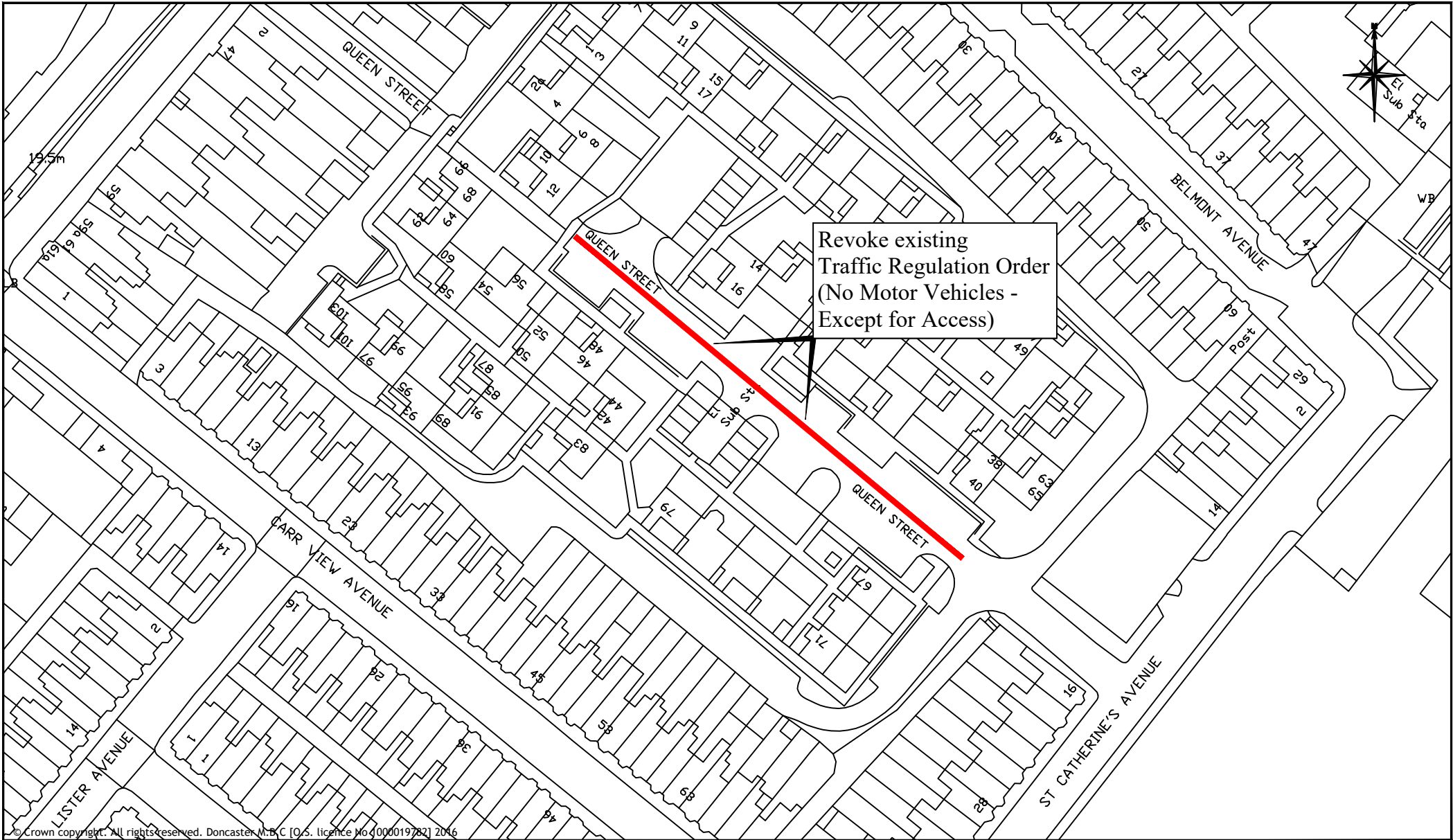

Notice is hereby given that on the 19<sup>th</sup> day of March 2025 the City of Doncaster Council made an Order under the provisions of the Road Traffic Regulation Act, 1984.

The effect of the Order that will come into operation on the 7<sup>th</sup> day of April 2025 will be to revoke the following item in Schedule 1.12 Prohibition of Driving except for access

QUEEN STREET From a point 37 metres northwest of its junction with St. Catherine's Avenue for a distance of 97 metres in a north westerly direction

If you wish to question the validity of the Order or of any of the provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1984, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order you may within six weeks from the 19<sup>th</sup> day of March 2025 apply to the High Court for this purpose.
