 - a) Barnsley Road, Scawsby

South West Side

- iii) From the western kerbline of the western leg of the unnamed road forming a lay-by outside Scawsby Ridgewood Comprehensive School for a distance of 15 metres in a westerly direction.
- Iv) From a point 15 metres east of the eastern kerbline of the unnamed access road forming the entrance to Stone Hill School for a distance of 37 metres in a westerly direction.
- b) Unnamed Road on the south west side of Barnsley Road forming a layby outside Ridgewood Comprehensive School Scawsby

Western Leg

West Side

- From its junction with the south western kerbline of Barnsley Road for a distance of 10 metres in a southerly direction.
- c) Unnamed Access Road forming the entrance to Stone Hill School, Scawsby

Both Sides

For a distance of 10 metres in a southerly direction.

This Order shall come into operation on the 10th day of February 2025 and may be cited as the "City of Doncaster Council (Various Roads, Doncaster) (Parking, Stopping, Waiting and Loading) (Consolidation) Order 2018 (Amendment No.88) Order 2025".

Notice is hereby given that on the 22nd day of January 2025 the City of Doncaster Council made an Order under the provisions of the Road Traffic Regulation Act, 1984.

The effect of the Order that will come into operation on the 10th day of February 2025 will be to introduce a No waiting Monday to Friday 8:00am to 6:00pm restriction on the following lengths of road:-

- a) Barnsley Road, Scawsby South West Side
- iii) From the western kerbline of the western leg of the unnamed road forming a lay-by outside Scawsby Ridgewood Comprehensive School for a distance of 15 metres in a westerly direction.
- Iv) From a point 15 metres east of the eastern kerbline of the unnamed access road forming the entrance to Stone Hill School for a distance of 37 metres in a westerly direction.
- b) Unnamed Road on the south west side of Barnsley Road forming a lay-by outside Ridgewood Comprehensive School Scawsby Western Leg West Side
 - i) From its junction with the south western kerbline of Barnsley Road for a distance of 10 metres in a southerly direction.
- c) Unnamed Access Road forming the entrance to Stone Hill School, Scawsby Both Sides

For a distance of 10 metres in a southerly direction.

Exceptions to the Order will permit waiting for the purpose of picking up and setting down passengers, loading and unloading goods, in connection with building industrial or demolition operations, the removal of obstructions to traffic, the maintenance of the roads and the services therein in pursuance of statutory powers or duties, for the collection and delivery of postal packets or if it is a vehicle being operated by or on behalf of the South Yorkshire Safety Camera Partnerships while carrying out roadside monitoring or enforcement operations. The usual exceptions for disabled persons vehicles are also included in the Order

A copy of the Order and a map showing the restricted roads may be examined at the Council Offices, Civic Office, Waterdale, Doncaster between 8.45 a.m. and 4.45 p.m. Monday to Friday or on the City of Doncaster Council Website via the following link https://www.doncaster.gov.uk/services/transport-streets-parking/made-orders

If you wish to question the validity of the Order or of any of the provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1984, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order you may within six weeks from the 22nd day of January 2025 apply to the High Court for this purpose.
