1 The City of Doncaster Council (Various Roads, Doncaster) (Parking, Stopping, Waiting and Loading) (Consolidation) Order 2018 shall have the effect as though the following items were included in Schedule 2.18 No waiting Monday to Friday 10am to 3pm:

Hillcrest Road, Wheatley

(a) North East Side

(i) From a point 25 metres north of its junction with the northern kerb line of Armthorpe Road for a distance of 40 metres in a northerly direction.

(ii) From a point 75 metres north of its junction with the northern kerb line of Armthorpe Road for a distance of 33 metres in a north westerly direction.

(b) South West Side

(i) From a point 25 metres north of its junction with the northern kerb line of Armthorpe Road for a distance of 45 metres in a northerly direction.

(ii) From a point 67 metres north of its junction with the northern kerb line of Armthorpe Road for a distance of 33 metres in a north westerly direction.



Notice is hereby given that the City of Doncaster Council proposes to make an Order under the provisions of the Road Traffic Regulation Act 1984 and all other enabling powers.

The effect of the Order will be to introduce a limited waiting restriction of No waiting Monday to Friday between the hours of 10am to 3pm on the following lengths of road:

Hillcrest Road, Wheatley

(a) North East Side

(i) From a point 25 metres north of its junction with the northern kerb line of Armthorpe Road for a distance of 40 metres in a northerly direction.

(ii) From a point 75 metres north of its junction with the northern kerb line of Armthorpe Road for a distance of 33 metres in a north westerly direction.

(b) South West Side

(i) From a point 25 metres north of its junction with the northern kerb line of Armthorpe Road for a distance of 45 metres in a northerly direction.

(ii) From a point 67 metres north of its junction with the northern kerb line of Armthorpe Road for a distance of 33 metres in a north westerly direction.

Exceptions to the Order will permit waiting for the purpose of picking up and setting down passengers, loading and unloading goods and in connection with building industrial or demolition operations, the removal of obstructions to traffic, the maintenance of the roads and the services therein in pursuance of statutory powers or duties, for the collection and delivery of postal packets or if it is a vehicle being operated by or on behalf of the South Yorkshire Safety Camera Partnerships while carrying out roadside monitoring or enforcement operations. The usual exceptions for disabled persons vehicles will also apply.
